- 2. Incomplete offer/lack of supporting documents will not be entertained. The authority may reject/cancel the tender offer or, whole process without showing any reason. The decision of the authority is final.

- 8. Work will be started after Administrative approval from the office of the Director, SCERT (WB).

## Other terms and conditions:

- The Security Guard will have to be given duty on daily attendance basis and duty hours 6PM to 7AM every day of the month.
- If any day is absent, one week in advance should inform and a replacement must be provided by the agency.
- Security Guard must wear agency dress and identity card.
- The agency should provide name, address and photo of the security guard

- The agency will fully responsible for any losses shortage, damage of Govt. Property during duty hours and the cost of the same as fixed by the authority will be recovered from the bills of the agency.
- If the service is not satisfactory the authority has every right to terminate the engagement of security guard at any time without assigning any reason what so ever.
- All liabilities arising out of accident or death while on duty shall be borne by the agency, as per relevant law are in force and as applicable.
- Torches and batteries if required for guarding will have to provide by the concerned agency at his own cost
